11:45 - 13:15	Balancing Disclosure Requirements with The Law of the People's Republic of China on Guarding State Secrets (<i>Hasofer, Illston, J., Potter*, Williams</i>) In a recent survey, 60% of respondents reported needing to collect data from China for investigations, arbitrations or litigation, by far more than any other country or region in the world. The Law of the People's Republic of China on Guarding State Secrets creates challenges for cross-border data transfers throughout the world, including those involving organizations in Hong Kong and other jurisdictions in the Asia Pacific region. Given the ever-increasing need for production of data located in China and the ever-present uncertainty surrounding the scope and applicability of the State Secrets Law, how are multinational companies and their legal counsel dealing with the competing obligations? Leading practitioners based in the Asia Pacific region will lead the dialogue on that issue. Also joining the panel is a U.S. federal judge, who will discuss how U.S. Courts address issues raised by the State Secrets law in cross-border discovery.
